### Manager Overview

### Investment Strategy

The Guardian Alternatives allocation offers a comprehensive solution for investors seeking returns through exposure to alternative investments and strategies. The portfolio is invested in ETFs, ETNs, closed-end funds or mutual funds that have been carefully selected with the goal of providing low correlation to traditional stock and bond asset classes. The securities selected invest in non-traditional assets, such as commodities, currencies, Master Limited Partnerships (MLPs), real estate and infrastructure or employ strategies that invest in traditional assets using non-traditional methods, such as short-selling, and leverage. The securities selected may also invest in equities issued by commodity or natural resource companies. The goal of the strategy is to enhance the overall risk and return characteristics of a portfolio by using alternative strategies that have historically exhibited low correlations with traditional asset classes like stocks and bonds.
