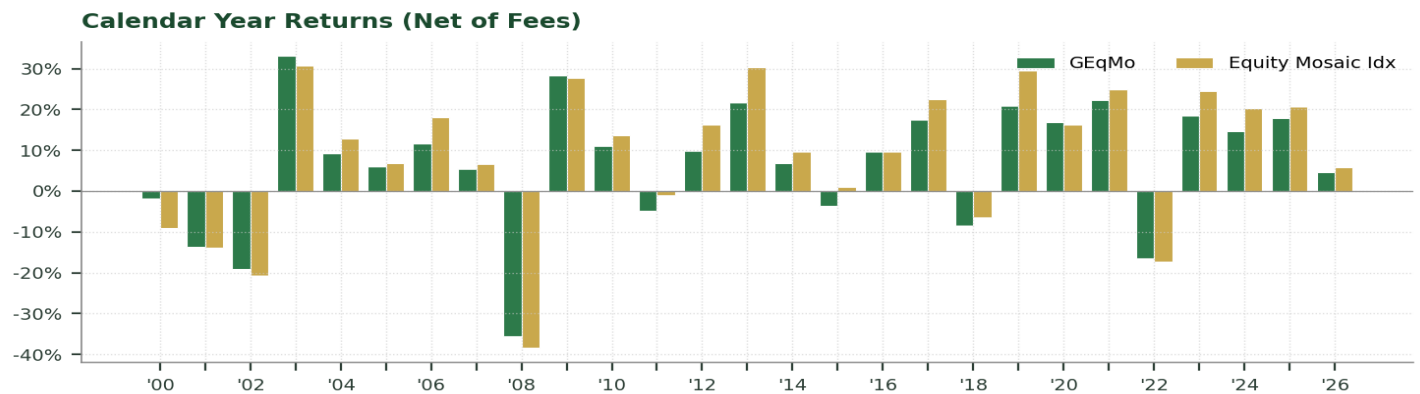
INVESTMENT STRATEGY

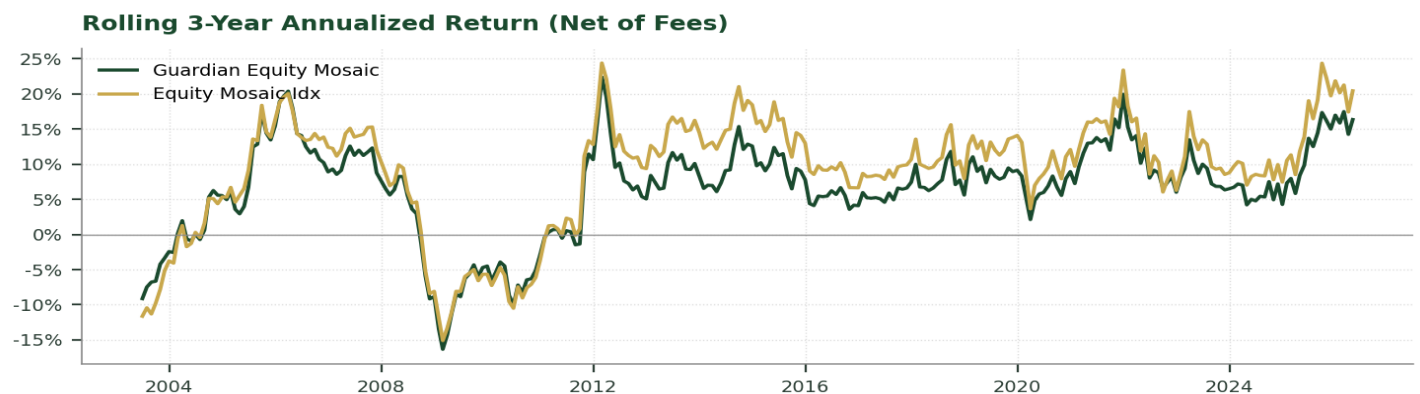
