Manager Overview

Investment Strategy

The Guardian Fixed Income allocation is a flexible fixed-income strategy tactically allocated in bonds between one end of the yield curve and credit quality spectrum to the other, commensurate with the economy's position in the interest rate cycle. When rates are low and the economy is improving, high yield corporate bonds may offer the most attractive spreads and returns. As rates rise and spreads narrow, a shortening of duration may be warranted. If the economy begins to weaken, returning to longer duration Treasuries can be an effective way to lock in higher yields and prices with the potential for gains if interest rates fall. The strategy is implemented predominantly with exchange traded funds.
