The strategy is directed by Saratoga Capital Management, LLC. Saratoga, founded in 1984, believes that asset allocation strategies utilized in a recession should be different than those employed in a full growth economy. They recognize that the overall economy is a fluid process made up of numerous economic sectors. Therefore, Saratoga regularly evaluates how individual sectors are affecting the general economy. They move past static asset allocation by suggesting updated strategies when investment environments change significantly.
