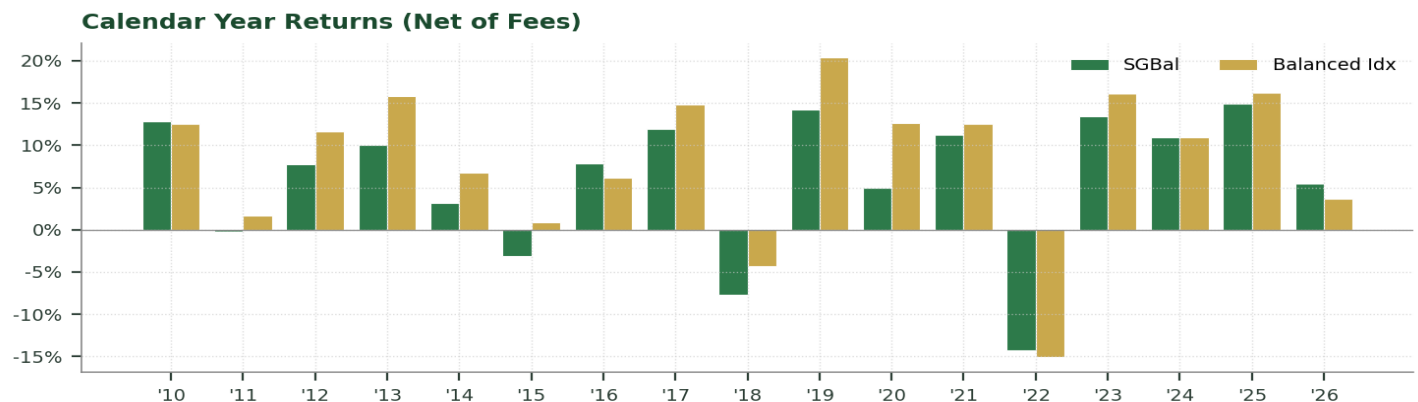
## INVESTMENT STRATEGY

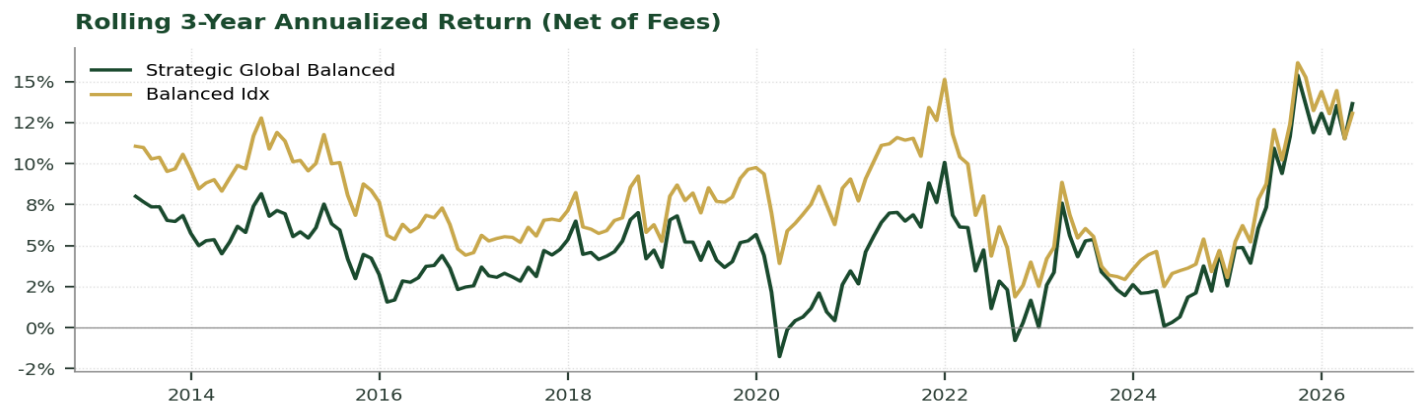
